In October 2015, there were 1,594 offenders released from CDCR prisons to PRCS. Of those, 1,246 (78.1%) were GP level, 296 (18.6%) were CCCMS level, 49 (3.1%) were EOP Level, 3 (0.2%) were MHCB level, and 0 (0%) were Acute Level of Care.
